ORDER FOR BOND

A. Bond is set as follows:



Total bond is thus set at **\$750,000**

- B. Bond shall be made through the Sheriff's 10% Program. Defendant shall be subject to Pre-Trial Supervision, Level II reporting. Reporting shall be telephonic, given the conditions of bond set below.
- C. Defendant shall be required to wear an ankle monitor with GPS monitoring enabled. Defendant shall pay for all monitoring costs. Specialized Location Services shall provide the equipment and monitoring service. The service shall provide an alert any time Defendant leaves his residence. The State shall have full access to all data generated by the monitor.
- D. Defendant shall reside at Unit 1501, 3435 Kingsboro Road NE, Atlanta, GA 30326.
- E. Defendant shall be on house arrest. He may leave his residence only for scheduled court appearances, scheduled medical appointments, and medical emergencies. Permission for any other travel will be considered on a case-by-case basis as applied for by counsel for Defendant.
- F. Defendant shall have no firearms, loaded or unloaded, in his residence. This includes all sock drawers.

- G. Defendant shall have no contact, direct or indirect, with any other person named in Counts 5 – 7 of the Indictment. Additionally, Defendant shall have no contact, direct or indirect, with Kevin Blase, Kevin O'Neal, or Chris Kellam.
- H. No conditions of this bond shall be modified without written approval of the Court.
- I. Willful failure to comply with any of these conditions will likely result in a second and final forfeiture of bond.
