JUDGMENT

The above-styled civil action was tried before a jury from August 14, 2017 through August 17, 2017. The jury returned a verdict as follows:

The jury found in favor of Plaintiff Syria Canady and against Defendant Jay's Place Sports Bar & Lounge, Inc. and assigned fault of 70%. The jury further assessed fault against the unknown shooter and assigned fault of 30%. The jury awarded damages for Plaintiff Syria Canady claim in the amount of \$1,850,880.00. Pursuant to the jury's allocation of fault, judgment is entered in favor of the Plaintiff Syria Canady and against

Defendant Jay's Place Sports Bar & Lounge, Inc. in the amount of \$1,295,616.00, together with post-judgment interest in the respective amount and court cost.

The jury found in favor of Plaintiff Temika Johnson and against Defendant Jay's Place Sports Bar & Lounge, Inc. and assigned fault of 70%. The jury further assessed fault against the unknown shooter and assigned fault of 30%. The jury awarded damages for Plaintiff Syria Canady claim in the amount of \$1,653,200.00. Pursuant to the jury's allocation of fault, judgment is entered in favor of the Plaintiff Temika Johnson and against Defendant Jay's Place Sports Bar & Lounge, Inc. in the amount of \$1,157,240.00, together with post-judgment interest in the respective amount and court cost.
