Tips for Searching Law.com Radar and Setting Alerts Using Claim Types

- Select a Practice Area, such as Labor & Employment, to conduct a broader search, or enter a specific Claim Type for more targeted searching.
- Be strategic when combining Practice Areas and Claim Types in the same search. For example, choosing Labor & Employment and Race Discrimination will yield a meaningful result set. However, a search for Copyright and Lemon Law Claims is unlikely to produce results.
- You can set up searches and alerts using federal Nature of Suit codes and/or SALI claim labels. Not sure which labels apply? Use a generic keyword (for example, 'contract') for generalized searching of all case type tags and metadata.
