On May 16, 2023, the Supreme Court of the State of Illinois entered an Order disbarring Helga Kahr from the practice of law. Upon notification of the action of the Supreme Court of the State of Illinois, this court issued an order, pursuant to ELC 9.2(c), directing Helga Kahr to inform this court of any claim that the imposition of identical discipline in the state would be unwarranted. Helga Kahr did not file a response. The Court reviewed the file in this matter and determined unanimously that the following order should be entered.

IT IS ORDERED:

The Washington State Supreme Court does hereby reciprocate discipline in the State of Washington and therefore Helga Kahr is disbarred from the practice of law. Pursuant to ELC 13.2, the effective date of disbarment is seven days from the date of this order.
