CALL OF THE DISMISSAL CALENDAR

The call of the Calendar required by section 600.12(c) of the Rules of Practice of the Appellate Division, First Department, will be held on Thursday, May 31, 2018 commencing at 10:00 a.m. at the Appellate Division Courthouse, Madison Avenue and 25th Street, New York, NY.

The Calendar to be called is published in this issue of the Law Journal and contains criminal appeals and all appeals involving Writs of Habeas Corpus which have not been brought on for hearing and in which poor person relief was granted prior to November 30, 2016 and civil appeals which have not been perfected within nine months from filing of record prior to August 31, 2017.

In the event the appellant or moving party fails to submit an affidavit with proof of service of a copy thereof, prior to or at the calendar call, satisfactorily explaining the delay in prosecuting the appeal, an order will be entered dismissing the appeal.

The affidavit required to be submitted shall contain the following information for criminal appeals:

- A. The nature of the order or judgment appealed from;
- B. The date of sentence;
- C. The date the notice of appeal was served;
- D. Whether any enlargement of time to perfect the appeal was granted
- E. The date of assignment.

For civil appeals the affidavit required to be submitted shall contain the following information:

- A. The nature of the order or judgement appealed from;
- B. The date the order or judgement appealed from was entered;
- C. The date the notice of appeal was served;
- D. Whether any enlargement of time to perfect the appeal was granted.
