E-Track allows counsel to list with the service some or all of the firm's cases that are pending in the Supreme Court, Civil Branch, New York County, and in other counties as well. E-Track provides notification by e-mail of all appearances and adjournments in covered cases that are recorded in the court's electronic case history program, as well as other developments, such as the reassignment of cases and the issuance of decisions and long-form orders. E-Track can also provide appearance reminders should counsel wish to avail themselves of that capability.
