Petitioner having applied to this Court for an order directing 59 attorneys, each of whom is named on the list attached hereto, to show cause why they should not be suspended from the practice of law on the ground that they have violated Judiciary Law § 468-a and 22 NYCRR 118.1 by failing to comply with attorney registration requirements,

NOW, upon reading and filing the affidavit of Daniel A. Drake, sworn to December 2, 2019, the affirmations of Daniel A. Drake, dated December 2 and 11, 2019, and due deliberation having been had thereon,

It is hereby **ORDERED** that each of the respondents named on the attached list is directed to show cause before this Court on or before March 27, 2020, by filing in this Court a written response to this order together with proof of service on counsel for petitioner, why an order should not be entered suspending the respondent from the practice of law for failing to comply with attorney registration requirements, and,

It is further **ORDERED** that, pursuant to Judiciary Law § 90 (6), petitioner is authorized to serve each of the named respondents with this order by: mailing a certified copy of this order to the respondent at the address that the respondent has provided to the Office of Court Administration; publishing a certified copy of this order in the New York Law Journal once each week for four consecutive weeks, commencing with the week of January 6, 2020, and ending with the week of January 27, 2020; and, posting a certified copy of this order on the website maintained by this Court for a minimum of thirty (30) days, commencing January 6, 2020.
