THE HOSPITAL UNTIL THE BODY REMOVAL SERVICES ARRIVED FOR THE CHILD. THIS
CONCLUDES MY INVOLVEMENT IN THIS CASE.

ON AUGUST 7, 2021, I RESPONDED TO PALMS WEST HOSPITAL EMERGENCY ROOM IN REFERENCE TO A DEATH INVESTIGATION. IT WAS REPORTED THAT EIGHTEEN -MONTH-OLD ENORA LAVENIR WAS FOUND UNRESPONSIVE WHILE CO-SLEEPING IN A BED WITH HER SISTER, FOURTEEN-YEAR-OLD TAMARA LAVENIR. ENORA WAS TRANSPORTED TO PALMS WEST HOSPITAL BY PALM BEACH FIRE RESCUE AND SHE WAS PRONOUNCED DECEASED. UPON ARRIVAL I MET DEPUTY M. CASAREZ #8044 WHO WAS POSTED OUTSIDE OF EXAM ROOM ONE. HE INFORMED ME ENORA LAVENIR ARRIVED AT THE HOSPITAL AND WAS TREATED IN EXAM ROOM ONE. HE EXPLAINED THAT THE ER DOCTOR PRONOUNCED HER DECEASED. FOR MORE INFORMATION, REFERENCE DEPUTY CASAREZ'S INVOLVEMENT PLEASE REFER TO HIS SUPPLEMENT.

I ENTERED EXAM ROOM ONE AND SAW ENORA LYING ON THE EXAM TABLE FACING UP. SHE HAD VARIOUS MEDICAL DEVICES ATTACHED TO HER. OTHER THAN THE TRAUMA CAUSED BY THE MEDICAL PROCEDURES I DID NOT NOTICE ANY VISIBLE SIGNS OF TRAUMA OR INJURY. WHILE IN EXAM ROOM ONE INVESTIGATOR CHRISTINE SIMONISE FROM THE PALM BEACH COUNTY MEDICAL EXAMINERS OFFICE ARRIVED. ALSO CRIME SCENE INVESTIGATOR STEPHANIE MAULER #25015 ARRIVED AND TOOK PHOTOGRAPHS AND GATHERED THE TOP THAT ENORA WAS WEARING. ALSO PRESENT AT THIS TIME WAS DCF CHILD PROTECTIVE INVESTIGATOR KAITLYN MARTINEZ.

I MET WITH CHARGE NURSE KRISTEN PATELSKY AND ATTENDING PHYSICIAN DR. DAVID SMITH IN EXAM ROOM ONE. DR. SMITH EXPLAINED, ENORA ARRIVED AT THE EMERGENCY ROOM AT 1539 HOURS ON AUGUST 7, 2021. ON ARRIVAL ENORA WAS IN CARDIAC ARREST AND WAS ALSO COLD TO THE TOUCH. HE BRIEFLY EXPLAINED SOME OF THE MEDICAL PROCEDURES HE PERFORMED AND SAID SHE WAS PRONOUNCED DEAD AT 1551 HOURS AUGUST 7, 2021. IN ADDITION, I WAS ALSO PROVIDED MEDICAL RECORDS OF ENORA'S

TREATMENT WHILE AT THE EMERGENCY ROOM. THESE RECORDS WERE LATER PLACED INTO EVIDENCE.

THE REMOVAL SERVICE FOR THE PALM BEACH COUNTY MEDICAL EXAMINER, ELITE REMOVAL ARRIVED AND TOOK POSSESSION OF ENORA. ONCE THIS WAS COMPLETE I RESPONDED TO THE RESIDENCE AT 1618 THE 12TH FAIRWAY WELLINGTON, FLORIDA 33414. ALSO RESPONDING TO THE LOCATION WAS CSI MAULER, ME INVESTIGATOR SIMONISE, AND DCF PI KAITLYN MARTINEZ.

ONCE AT THE SCENE I MET WITH SVU DETECTIVE DERRICK GENTILCORE #8403.

DETECTIVE GENTILCORE BRIEFED ME ON THE SITUATION AT THE RESIDENCE AND ASSISTED IN HAVING THE CONSENT TO SEARCH FORM SIGNED. ONCE THE FORM WAS SIGNED CSI MAULER PHOTOGRAPHED THE CRIME SCENE. CSI MAULER ALSO VIDEOTAPED THE WALK THRU INTERVIEWS PERFORMED AT THE SCENE. IN ADDITION, FOLLOWING THE INTERVIEWS SHE COLLECTED THE FOLLOWING FROM THE BEDROOM, THE BOTTOM FITTED SHEET, PILLOW CASE, A BABY BOTTLE FROM THE SIDE OF THE BED, AND FORMULA FROM THE KITCHEN. FOR MORE INFORMATION, REFERENCE THESE ACTIONS REFER TO CSI MAULER'S CRIME SCENE REPORT.

IT WAS LEARNED ENORA'S FAMILY IS FROM THE FRENCH ISLAND OF GUADELOUPE AND THEY SPEAK FRENCH AND ONLY UNDERSTAND LIMITED ENGLISH. PALM BEACH COUNTY SHERIFF'S OFFICE COMMUNICATIONS WAS ABLE TO LOCATE DETECTIVE MARTIN GAREAU WHO WAS ABLE TO RESPOND TO THE SCENE AND ASSIST WITH TRANSLATION. DETECTIVE GAREAU ASSISTED WITH THE WALK THRU VIDEOS AND THE INTERVIEWS.

ONCE DETECTIVE GAREAU RESPONDED THE WALK THRU VIDEOS WERE CONDUCTED. PRESENT FOR THE VIDEOS WERE ME INVESTIGATOR CHRISTINE SIMONISE, DCF PI KAITLYN MARTINEZ, DETECTIVE GENTILCORE, DETECTIVE GAREAU FOR TRANSLATION. THE VIDEO WAS CONDUCTED BY CSI MAULER. THE FOLLOWING ARE BRIEF SUMMARIES OF THE VIDEOS FOR COMPLETE DETAILS AUTHORIZED PERSONS SHOULD REFER TO THE COPIES UPLOADED TO THE PALM BEACH COUNTY COMMANDER SYSTEM.

THE FIRST VIDEO WAS DONE BY LYDIE LAVENIR ON AUGUST 7, 2021 AT 754 PM. LYDIE EXPLAINED PRIOR TO DISCOVERING HER DAUGHTER ENORA NON RESPONSIVE SHE WAS TAKING A NAP AROUND 230 PM SHE WOKE UP GOT SOMETHING TO DRINK AND WENT TO CHECK ON THE KIDS. SHE WENT TO TAKE A NAP AROUND 1200 PM AND ENORA WAS AWAKE IN THE LIVING ROOM AREA.

NEXT SHE WENT INTO THE BEDROOM AREA TO SHOW US HOW SHE DISCOVERED ENORA. SHE TOOK THE DOLL AND PLACED HER ON THE BED ON THE LEFT SIDE AS YOU FACE THE BED. ENORA WAS LYING ON HER RIGHT SIDE FACING THE WALL. HER OLDEST DAUGHTER TAMARA WAS LYING ON THE RIGHT SIDE OF THE BED AS YOU FACE IT. TAMARA WAS ALSO ON HER RIGHT SIDE FACING THE SAME WALL AS ENORA. TAMARA'S LEFT ARM WAS PLACED OVER THE LOWER PORTION OF ENORA AROUND THE HIPS. SHE SAW ENORA'S FACE WAS BLUE. LYDIA ATTEMPTED TO DO CPR ON ENORA WHILE THE OTHERS IN THE HOUSE WERE CALLING 911. SHE DEMONSTRATED HOW SHE FOUND ENORA, SHE SCREAMED AND BEGAN CPR. SHE NOTICED THE ENORA'S T-SHIRT WAS WET WHEN SHE FOUND HER AND THERE WAS SOME

THERE WERE NO KNOWN CONDITIONS WHICH WOULD CAUSE ENORA TO GET ILL. SHE DID
HAVE ISSUES WITH REGURGITATING WHEN SHE WAS YOUNGER BUT THAT HAD STOPPED. THE
LAST TIME LYDIA FED ENORA WAS THE PREVIOUS NIGHT. ENORA HAD FRIES, SOME SMALL
BITS OF MEAT. LYDIA DEMONSTRATED THE POSITION TAMARA WAS IN WHEN SHE
DISCOVERED ENORA.

THIS CONCLUDED THE WALK THRU VIDEO WITH LYDIA LAVENIR.
THE NEXT VIDEO WAS DONE WITH TAMARA LAVENIR AUGUST 7, 2021, PRIOR TO
CONDUCTING THE VIDEO TAMARA WAS QUALIFIED ON THE DIFFERENCE BETWEEN TELLING
THE TRUTH AND TELLING A LIE THROUGH THE USE OF EXAMPLES.
PRIOR TO GOING TO SLEEP IN THE BEDROOM TAMARA AWOKE AROUND 7:00 AM SHE MADE
PANCAKES. SHE ATE AND NOTICED ENORA WAS WAKING UP. SHE WENT TO THE ROOM GOT
ENORA UP AND FEED HER A BOTTLE OF FORMULA ABOUT 10 OUNCES. SHE DRANK THIS
AFTER 8:00 AM. ENORA WAS SITTING AT THE KITCHEN COUNTER FOR A WHILE. TAMARA
WAS WATCHING TV IN THE LIVING ROOM. TAMARA, HER BROTHER TIMEO, AND ENORA WENT
INTO THE BEDROOM AND WERE PLAYING. AROUND 11:30 AM ENORA WAS TIRED SO TIMEO
LEFT THE ROOM AND TAMARA AND ENORA LAID DOWN ON THE BED AND TOOK A NAP. PRIOR
TO THE NAP ENORA HAD A BOTTLE AND A BIT OF A STRAWBERRY.

TAMARA AND HER MOTHER WENT INTO THE BEDROOM, TAMARA PLACED THE DOLL ON THE BED
DEMONSTRATING WHERE ENORA WAS ON THE BED. TAMARA PLACED THE DOLL ON THE LEFT
SIDE OF THE BED AS YOU FACE IT. THE DOLL WAS ON THE RIGHT SIDE FACING THE
WALL TO THE LEFT. TAMARA WAS LYING NEXT TO ENORA TO THE RIGHT. TAMARA WAS ON
HER RIGHT SIDE WITH HER RIGHT ARM ABOVE ENORA BY HER HEAD. WHEN SHE WOKE UP
THE FIRST THING SHE RECALLED WAS ENORA WAS ON HER BACK TO THE RIGHT OF HER,
HER MOTHER LYDIA WAS SCREAMING.

TAMARA DOES NOT RECALL ANYTHING FROM THE TIME SHE FELL ASLEEP TO WHEN SHE WAS
AWOKEN BY HER MOTHER SCREAMING. SHE DEMONSTRATED THE POSITION SHE RECALLS
BEING IN PRIOR TO HER FALLING ASLEEP. ENORA'S BACK WAS TO TAMARA'S FRONT AND
TAMARA WAS NOT ON TOP OF ENORA AND HER ARMS WERE NOT OVER ENORA. WHEN SHE
AWOKE SHE NOTICED THE WETNESS ON THE BED. TAMARA IDENTIFIED THE BOTTLE ON THE
RIGHT SIDE OF THE BED AS THE ONE SHE FED ENORA AROUND 10:00 PM ON AUGUST 6,
2021. THIS CONCLUDED THE VIDEO WITH TAMARA.

FOLLOWING THE WALK THRU VIDEOS I CONDUCTED A INTERVIEWS WITH BORIS LAVENIR,
LYDIE LAVENIR, SANDRO LAVENIR AND TAMARA LAVENIR. PRESENT FOR THE INTERVIEWS
WAS DETECTIVE MARTIN GAREAU AND DCF PI KAITLYN MARTINEZ. THE FOLLOWING IS A
SUMMARY OF THE INTERVIEWS FOR COMPLETE DETAILS AUTHORIZED INDIVIDUALS SHOULD
REFER TO THE COPIES OF THE INTERVIEWS WHICH WERE SENT TO THE PHOTO LAB FOR
UPLOAD TO THE COMMANDER SYSTEM.

THE FIRST INTERVIEW WAS WITH BORIS LAVENIR WHO IS THE FATHER OF ENORA LAVENIR.
PRESENT FOR TRANSLATION OF THE INTERVIEW IS DETECTIVE GAREAU AND ALSO PRESENT
WAS DCF PROTECTIVE INVESTIGATOR KAITLYN MARTINEZ. THE FIRST PART OF THE

INTERVIEW INVOLVED GATHERING HIS PERSONAL INFORMATION.
BORIS IS ENORA'S BIOLOGICAL FATHER. HE HAS FIVE CHILDREN WITH HIS CURRENT WIFE LYDIE AND TWO CHILDREN WITH ANOTHER WOMAN. TWO BOYS AND THREE GIRLS, SANDRO, TAMARA, NATHEO, TIMEO, AND ENORA.
BORIS EXPLAINED THE PREGNANCY WITH ENORA WAS NORMAL AND THERE WAS NOTHING OUT OF THE NORMAL. HE SAID HE WORKS MANY HOURS AND HE WAS NOT TOO INVOLVED WITH THE PREGNANCY BUT SAID SHE DELIVERED TEN DAYS LATE. THE DELIVERY WAS NORMAL. HIS WIFE EXPERIENCED A GREAT DEAL OF PAIN BUT THE DELIVERY WAS NORMAL. THERE WERE NO MEDICAL ISSUES WITH ENORA ON DELIVERY. THEY WERE RELEASED FROM THE HOSPITAL IN THREE OR FOUR DAYS.
FROM THE TIME OF BIRTH TO THE PRESENT HE NOTED NO PHYSICAL PROBLEMS. HOWEVER, HE EXPLAINED BECAUSE OF THE COVID PANDEMIC SHE WAS NOT EXPOSED TO MANY OTHER PEOPLE. HE SAID SHE WAS A LITTLE ANTISOCIAL BUT NO PHYSICAL PROBLEMS. HE COULD NOT SPEAK INTELLIGENTLY ABOUT ENORA'S FOLLOW UP VISITS WITH HER DOCTORS. ENORA'S MOTHER HANDLED THIS PART BECAUSE OF HIS HECTIC WORK SCHEDULE. ALTHOUGH HE WAS NOT AWARE OF ANY ISSUES WITH HER DEVELOPMENT. HE ALSO CONFIRMED THERE IS NO KNOWN EXPOSURE TO THE CORONA VIRUS.
BORIS OUTLINED THE PREVIOUS TWENTY-FOUR HOURS PRIOR TO ENORA'S DEATH. THE TRIP TO FLORIDA STARTED WITH THE FAMILY TRAVELING TO THE AIRPORT. ON AUGUST 6, 2021 AT APPROXIMATELY 9:20 AM THE FAMILY TRAVELED TO THE AIRPORT IN TWO CARS. BORIS DROPPED HIS CAR AT WORK DROVE THE FAMILY TO THE AIRPORT IN THE OTHER VEHICLE. HE DROPPED THEM AT THE AIRPORT AND WENT TO HIS MOTHER IN-LAWS HOUSE AND LEFT THE VEHICLE. HE WAS GIVEN A RIDE TO THE AIRPORT TO MEET HIS FAMILY.
THE FAMILY ARRIVED AT MIAMI INTERNATIONAL AIRPORT APPROXIMATELY 12:20 PM. THERE IS NO TIME DIFFERENCE IN MIAMI TO GUADELOUPE. THEY WAITED ABOUT 20 MINUTES FOR THE STROLLER AND WENT TO NATIONAL CAR RENTAL. THEY LEFT NATIONAL CAR RENTAL APPROXIMATELY 1:30 PM AND DROVE AND DROVE ONE AND ONE HALF HOURS TO THE HOUSE ARRIVING AROUND 3:00 PM. THEY MET WITH THE HOME OWNER WHO RENTED THE HOUSE TO THEM AND TALKED FOR A FEW MINUTES.
NEXT, THEY LEFT TO GET FOOD. THEY GOT TAKEOUT FOOD THE FORD GARAGE RESTAURANT AND WENT TO PUBLIX TO GET FOOD AND DRINKS FOR THE VACATION. THEY ATE THE FOOD AT HOME AROUND 7:30 PM. AFTER THEY ATE EVERYONE WAS WATCHING TV AND PLAYING ON THEIR PHONES. HE BELIEVES ENORA WENT TO BED LATE BUT DOES NOT KNOW THE SPECIFIC TIME. HE DOES NOT KNOW WHO PUT HER TO BED. HE WOKE UP AROUND 7:30 AM AND HE SAW TAMARA AWAKE AT 7:30 AM
THE OTHER KIDS STARTED WAKING UP, ENORA BROUGHT HIM HIS SLIPPERS AROUND THE SAME TIME. HE FELL BACK ASLEEP ON THE COUCH AND REMEMBERS WAKING UP AND ALL FIVE OF THE KIDS WERE WATCHING TV. HE FELL BACK ASLEEP. HE WOKE UP SAW THE WIFE WALK THROUGH THE LIVING ROOM. HE WENT TO THE KITCHEN TO GET MILK. HE HEARD SOMEONE SCREAM, FROM THE ROOM ENORA WAS SLEEPING IN, "ENORA IS DEAD."

HE WENT TO THE ROOM SAW HIS SON SANDOR AND TOLD HIM TO CALL 911. HIS WIFE LYDIE WAS AT THE BOTTOM OF THE BED AREA. ENORA WAS LAYING OFF TO THE LEFT SIDE OF THE BED AS YOU LOOK AT IT. TAMARA WAS LYING TO THE RIGHT OF ENORA. HE SAW A LITTLE WHITE STUFF NEXT TO HER MOUTH. HE SAID IT LOOKED LIKE SHE WAS SLEEPING. THE PARAMEDICS ARRIVED AND CAME IN THE ROOM. THEY TOOK ENORA TO THE HOSPITAL AND HE RESPONDED TO THE HOSPITAL. BORIS EXPLAINED THAT IN THE LAST TWENTY-FOUR HOURS ENORA HAD TWO FALLS. ONE OCCURRED AT MIAMI AIRPORT WHEN THE STROLLER FELL OVER. HE DID NOT WITNESS THE FALL AND SAW NO SIGNED OF INJURIES, NO CHANGE IN ENORA'S BEHAVIOR. THIS CONCLUDED THE INTERVIEW WITH BORIS LAVENIR. NEXT, I INTERVIEWED LYDIE LAVENIR THE BIOLOGICAL MOTHER OF ENORA. PRESENT FOR THE INTERVIEW WAS DETECTIVE GAREAU AND KAITLYN MARTINEZ FROM DCF. THE FIRST PART OF THE INTERVIEW INVOLVED GATHERING LYDIE'S PERSONAL INFORMATION. SHE HAS FIVE CHILDREN WITH BORIS AND THEY ARE LISTED ABOVE. DURING ENORA'S PREGNANCY SHE HAD CONTRACTIONS THE LAST THREE OR FOUR MONTHS OF PREGNANCY AND WAS BEDRIDDEN UNTIL SHE GAVE BIRTH. ENORA WAS BORN THROUGH NATURAL CHILD BIRTH AND WAS A WEEK LATE. THERE WERE NO OTHER ISSUES DURING THE PREGNANCY. THEY REMAINED IN THE HOSPITAL FOR THREE DAYS AFTER DELIVERY. THERE WERE NO MEDICAL ISSUES AFTER HER BIRTH. ONCE THEY GOT HOME THERE WAS A MINOR ISSUE WITH BREASTFEEDING BUT THIS WAS RESOLVED. FROM THE TIME OF BIRTH UNTIL THEY WENT ON VACATION ENORA'S HAS HAD NO MAJOR MEDICAL ISSUES OR INJURIES. SHE HAS HAD NORMAL CHECKUPS AND IS NORMAL FOR GROWTH AND DEVELOPMENT. SHE HAS HAD SOME COLLEAGUES AT WORK WHO HAVE HAD COVID BUT NO ONE CLOSE TO ENORA HAS HAD COVID. THE AUTOPSY OF THE DESCENDANT WAS PERFORMED ON 8/8/21, AND WAS POSITIVE FOR FENTANYL IN THE BLOOD. ON EXAM OF THE ORGANS, THE HEART, SPLEEN, KIDNEY AND LIVER WERE REPORTED TO BE ENLARGED, AND THERE WAS NOTED CEREBRAL EDEMA. THE VIRAL CULTURE OF THE LUNGS WAS POSITIVE FOR RSV (RESPIRATORY SYNCYTIAL VIRUS), WITH CONSISTENT HISTOLOGICAL CHANGES. DESPITE THE NOTED ENLARGED ORGANS AS NOTED ABOVE, THE HISTOLOGY OF THE ORGANS WAS NORMAL FOR EACH ONE. IT WAS RECORDED THAT IT WAS UNKNOWN HOW THE DECEDENT INGESTED THE FENTANYL AND THE SOURCE OF THE FENTANYL. "THERE WERE NO SIGNS OF ANY ILLEGAL NARCOTICS AT THE CRIME SCENE. THE PARENTS TESTED NEGATIVE FOR ANY DRUG."

WHEN THE FAMILY ARRIVED AT THE RESIDENCE THEY WERE GREETED AT THE RESIDENCE BY THE RENTAL AGENT ALEX TIMPY WHO'S PICTURE IS ON THE AIRBNB WEBPAGE FOR THE RESIDENCE. ALSO PRESENT WAS AN UNKNOWN BLACK MALE WHO WAS FIXING A WINDOW ON THE FIRST ROOM ON THE LEFT. HE DID NOT LOOK LIKE A PROFESSIONAL HANDY MAN OR MAINTENANCE WORKER JUST LIKE SOMEONE WHO WAS HELPING ALEX FIX THE WINDOW. LYDIE LAVENIR CONFIRMED THE FAMILY DID NOT RENT THE RESIDENCE UNTIL THEY ARRIVED AT THE AIRPORT IN MIAMI. SHE DESCRIBED THE HOUSE AS BEING CLEANED THERE WERE FRESH SOAPS, TOWELS, IN THE BATHROOM AND THE HOUSE APPEARED TO HAVE BEEN CLEANED. HOWEVER, IT DID NOT HAVE THE APPEARANCE OF A PROFESSIONALLY CLEANED VACATION HOTEL, SHE GAVE EXAMPLES OF THE RITZ HOTEL.

LYDIE EXPLAINED SHE HAD RESEARCHED IT AFTER RECEIVING THE AUTOPSY REPORT. IT WAS AFTER THIS THAT SHE RESEARCHED FENTANYL EVEN CONSULTING WITH DOCTORS TO EDUCATE HERSELF ON THIS DRUG. I ASKED BORIS AND LYDIE DIRECTLY IF ANYONE IN THEIR FAMILY OR EITHER OF THEM HAVE BEEN PRESCRIBED FENTANYL, THEY ANSWERED "NO." I ASKED IF EITHER OF THEM HAD BROUGHT ANY FENTANYL INTO THE COUNTRY, THEY ANSWERED "NO." I ASKED IF THEY HAD OBTAINED ANY FENTANYL WHILE THEY WERE HERE IN THIS COUNTRY, THEY ANSWERED "NO." THEY DENIED ANY ONE OF THEM OR ANY ONE IN THEIR IMMEDIATE FAMILY SUFFER FROM ANY SEVER ILLNESS.

BORIS AND LYDIE WERE ASKED IF THEY HAVE ANY THEORIES ABOUT HOW THE FENTANYL WOULD HAVE GOTTEN INTO THEIR DAUGHTER'S BODY. THEY HAD SPOKEN TO A DOCTOR ABOUT THE ISSUE AND THE DOCTOR BELIEVED IT IS POSSIBLE THE FENTANYL COULD HAVE BEEN IN THE SHEETS. HOWEVER, BORIS SAYS SHE WAS IN THE SHEETS BEFORE AND BELIEVES THIS IS NOT REASONABLE.

LYDIE DESCRIBED ENORA AS VERY ACTIVE SHE IS ABLE TO CLIMB AND MOVE AROUND EASILY. SHE WAS VERY EXCITED AT THE HOUSE BECAUSE IT WAS A NEW ENVIRONMENT SO SHE WAS MORE ACTIVE. SHE SAID, ENORA WAS NOT KNOWN TO PUT ITEMS IN HER MOUTH BUT AS A CHILD SHE WAS CURIOUS AND WOULD PICK ITEMS UP AND HANDLE THEM. OTHER THAN THE RENTAL AGENT ALEX AND THE GENTLEMAN WHO WAS FIXING THE WINDOW THEY HAD NO OTHER VISITORS AND NO ONE ELSE WAS IN THE HOUSE. WHEN THEY ARRIVED AT THE HOUSE BORIS BELIEVES THERE MAY HAVE BEEN ITEMS IN THE REFRIGERATOR BUT RECALLS THESE ITEMS WERE SEALED. THEY DID NOT MEET ANY OF THE NEIGHBORS WHILE AT THE RESIDENCE.

AS FOR THE USE OF THE COCAINE AARON STATED IT WAS UTILIZED ON THE KITCHEN ISLAND AREA OF THE RESIDENCE.

OTHER THAN THE INDIVIDUALS IN HIS GROUP NO OTHER INDIVIDUALS CAME TO THE HOUSE. HE DESCRIBES THE HOUSE AS BEING VERY CLEAN THERE WERE NO ISSUES WITH THE CLEANLINESS OF THE RESIDENCE. HE HAS NO EXPLANATION AS TO HOW FENTANYL WOULD HAVE GOT INTO THE RESIDENCE. HE DOES NOT RECALL SEEING ANY SIGNS OF ANY MATERIAL WHICH HE WOULD CONSIDER TO BE FENTANYL.

THIS CONCLUDED THE INTERVIEW WITH AARON KORNHAUSER.

I AM AWAITING A SUBPOENA FOR THE RECORDS OF YULIA ALEX TIMPY WHO IS THE LICENSED REAL-ESTATE SALES ASSOCIATE RESPONSIBLE FOR RENTING THE UNIT ON AIRBNB.

THIS CASE IS AN INFORMATION REPORT IN REFERENCE TO THE ACCIDENTAL INGESTION OF THE FENTANYL. I AM STILL UNABLE TO DETERMINE THE SOURCE OF THE FENTANYL. PENDING CONTACT FROM THE RENTERS AND SUBPOENA FOR YULIA.
