2. SOM's Motion to Dismiss is **DENIED** and SOM shall answer the Amended

Complaint within twenty (20) days of its filing (presuming that the Amended Complaint does not

alter the allegations against SOM).

3. Owners' Motion to Dismiss is **GRANTED** with leave for ADF to amend within

ten (10) days from the date of this Order.
