If confirmed, I will recuse in any litigation in which I have ever played a role. I would also recuse myself from any matter involving my family, close friends, and my own financial interests. I will evaluate any other real or potential conflict, or relationship that could give rise to an appearance of conflict, on a case-by-case basis with the advice of parties and their counsel, in order to determine appropriate action, including recusal where necessary.

If confirmed, I will review and address any potential conflicts using 28 U.S.C. 455, Canon 3 of the Code of Conduct for United States Judges, and any other applicable laws, rules, and practices.

Since joining the bar, I have worked exclusively in jobs with public-service responsibilities, as a prosecutor and then as an appellate lawyer for the federal government. Each of these positions substantially restricts outside legal work, even when performed on a pro bono basis. However, I have volunteered, with Department of Justice authorization, for the component of the DC Volunteer Lawyers Project that assists domestic-violence victims in obtaining protection orders. In law school, I also volunteered with a program providing pro bono assistance in immigration law.

In early March 2017, I discussed with a lawyer in the White House Counsel's Office the possibility of being considered for one of the judicial vacancies in New York. I then submitted a resume to the White House Counsel's Office. I interviewed at the White House Counsel's Office on March 16, 2017, and have had several additional contacts with attorneys from that office since then.

On November 20, 2017, I interviewed by telephone with a member of Senator Schumer's screening panel for judicial appointments.

On November 21, 2017, a staff member in the White House Counsel's Office asked that I complete paperwork for an FBI background check.

On November 28, 2017, an attorney in the Office of Legal Policy at the Department of Justice asked that I complete additional vetting paperwork. I have had additional communications with representatives of that office since then.

On April 24, 2018, I interviewed with Senator Schumer and several of his aides. I also had a brief phone call with Senator Schumer on May 9, 2018, and several e-mail communications with one of Senator Schumer's aides.

On May 15, 2018, President Trump submitted my nomination to the Senate.

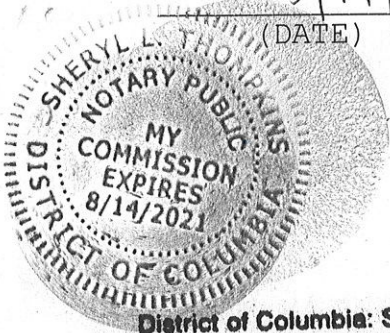
