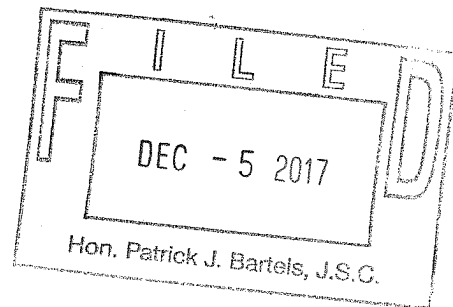


**CONSENT ORDER**

THIS MATTER, having been presented to the Court by Glenn A. Bergenfield, Esq., counsel for Plaintiff Brian Delaney ("Plaintiff"), and the Honorable Walter Koprowski, Jr., P.J.Ch., of the Superior Court of New Jersey, Chancery Division, Essex County, having determined on the record on November 9, 2017, that the dispute between Plaintiff and Defendant Trent Dickey, Esq. ("Dickey") and Defendant Sills Cummis & Gross, P.C. ("Sills"), regarding legal malpractice may only proceed by arbitration before JAMS (the "Decision"), and Plaintiff and Sills having consented to the form and contents of this Order, and good cause having been shown,

On this 5<sup>th</sup> day of December, 2017,

IT IS ORDERED that Plaintiff's claims against Dickey and Sills be and hereby are dismissed without prejudice; and it is further

ORDERED that Plaintiff's claim for legal malpractice may only proceed by arbitration in accordance with the Decision, and all of the parties' arguments concerning whether Plaintiff's claim for legal malpractice may be brought in the pending arbitration (JAMS Ref # 1425021907) or in a separate arbitration that Plaintiff will file with JAMS are reserved to be decided by the arbitrator.
