action, Applicant simply cannot financially afford to continue to defend himself in this action.


Applicant prays that his name be dropped and deleted from the list of persons licensed to

#### TO THE HONORABLE SUPREME COURT OF TEXAS:

Pursuant to the Texas Rules of Disciplinary Procedure, the Chief Disciplinary Counsel of the State Bar of Texas, acting by and through the Commission for Lawyer Discipline, hereby files this Response to the Motion for Acceptance of Resignation in lieu of discipline filed by RICHARD E. JACKSON, State Bar No. 10492980, and would show as follows:

I.

The acceptance by the Court of the Resignation of RICHARD E. JACKSON is in the best interest of the public and of the profession.

II.

The following allegations of Professional Misconduct are pending:

Commission for Lawyer Discipline v. Richard E. Jackson, Case Number 201806646

Beginning in 1999, Respondent was the lead assistant district attorney assigned to prosecute Stanley Mozee (Mozee) and Dennis Allen (Allen) for the murder of Reverend Jesse Borns, Jr. Respondent failed to disclose evidence that tended to negate the guilt of Mozee and Allen to defense counsel. Specifically, the allegations are that Respondent failed to make timely disclosure to the defense, agreements Respondent made with informants in exchange for their favorable testimony for the State; details related to eyewitnesses' identification or description of Mozee and Allen or alleged suspect; and, interview reports or statements from eyewitnesses.

The above facts support a violation of Rule 3.09(d) of the Texas Disciplinary Rules of Professional Conduct.

#### III.

**WHEREFORE**, the State Bar of Texas moves the Court to accept the resignation in lieu of discipline and grant the motion filed by Applicant.
