Under Pennsylvania Rule of Civil Procedure 229(c), "[t]he court, upon petition and after notice, may strill off a discontinuance in order to protect the rights of any party from unreasonable inconvenience, vexation harassment, expense, or prejudice." Pa. R.Civ.P.229(c). "In determining whether to strike discontinuance, 'the trial court must consider all facts and weigh equities. Further, the trial court must consider the benefits or injuries which may result to the respective sides if a discontinuance is granted Pohl v. NGK Metals Corporation, 936 A.2d 43, 47 (Pa. Super. 2007) (quoting Foti v. Askinas, 639 A. 807, 808 (1994)), appeal denied, 952 A.2d 678 (2008). Although this case has been pending for over four and one-half years, the Court nevertheless finds that the City's participation has not been so extensive and resource-consuming that it would be unreasonably unduly prejudicial or inconvenient not to strike POM's discontinuance.
