

On 09/18/23 at 11:51 pm, 9th District Officers responded to a radio call for a "Person with a gun" on the 1400 block of Walnut Street, located in the City and County of Philadelphia. Upon Police arrival, the complainant V.A. was located by Officers near Broad and Walnut Street suffering from gunshot wound to his right calf. The victim was immediately transported to Jefferson Hospital by responding officers. The victim was treated and listed in stable condition by Dr. Jenoff. Police Officers surveyed the area for a crime scene and located one fired cartridge casing (FCC) on the sidewalk in front of 1420 Walnut Street. The scene was secured and held as a crime scene, and the Shooting Investigation Group (SIG) was notified.

SIG Detectives Andrew #766 & Det. Fleming #758 responded to Jefferson Hospital and interviewed the victim V.A., he stated in summary that he was at the cigar bar located at 1522 Walnut Street. After leaving, he was involved in a verbal altercation with two unknown males. The victim states that during the altercation he heard approximately three to five gunshots, and he ran towards Broad Street. While running, he stated that he realized he was shot in the right calf area. The victim was able to flag down responding Officers on Broad & Walnut St and was transported to Jefferson Hospital. The complainant could only describe one of the offenders as a B/M, tall, bald, all dark clothing. The second male he could only describe as short.

On 9/19/23, Shooting Investigation Group was contacted by an eye witness known as M.H. She came forward and was later interviewed at SIG H.Q. at 400 N. Broad St. During the interview, she stated that she was on a date with the victim V.A. on the night of the shooting. She stated that the victim V.A. became gradually intoxicated throughout the night and became verbally abusive towards her. She stated she attempted to get away from V.A. and walked into the cigar bar located at 1500 block of Walnut St. She approached employees at the Cigar bar and told them she was attempting to get away from V.A. At that point the bar manager C.M. later identified as an eye witness, escorted her to her to her vehicle. She stated she heard multiple gunshots in the direction of the cigar bar, but did not see who was shooting or if anyone was shot.

M.H and the victim V.A described the offender was a B/M, dark complexion, muscular build, wearing a dark sweater and jeans. Photo arrays were prepared by the assigned, and was later shown to both M.H & V.A by Detectives Scott #7603 & Ruddy #959 with negative results. Both the witness and victim stated that they only briefly saw the offender and was unable to identify him.

The assigned, along with Det. Gilson #7609, processed the crime scene located at 1420 N. Broad Street. The scene consisted of (1) .380 caliber FCC at 1420 Walnut Street. The scene was photographed and sketched for accuracy. Surveillance footage was recovered by Detectives Glaviano #796 & Det. Corson #605 at 1420 Walnut St. The surveillance footage captures the shooting in its entirety. The bar manager later identified as C.M. identifies himself and the offender in the video. He was observed on camera standing next to the offender during the altercation and shooting. The offender produces a black firearm, and appears to shoot V.A. two times. Shooting at V.A. when initially confronted, and then again as V.A. is clearly running away from the offender, and does not appear to be a threat to the offender. The second gunshot taken by the offender strikes the victim in the right calf. All parties move away from screen after the shooting. After surveillance footage was recovered, the assigned contacted C.M. and conduct an interview at SIG HQ located at 400 N. Broad St. During the interview, C.M identifies Leonard Keith Hill DOB: 11/04/1969 of 208 Garnet Ln, Bala Cynwyd PA, 19004 as the offender. He states that he is a friend of Mr. Hill, and that he frequents the cigar bar at 1500 Walnut St. He identified the offender by signing a single image of the offender. Stating he has seen him hundreds of times, possibly (thousands of times) prior to the night of the shooting. He did state he believed that Mr. Hill was acting in self-defence of both himself and the offender, but also states that the offender never once called 9-11 following the incident. C.M also states that the offender MR. Hill goes to his vehicle after the shooting and changes his clothing prior to Police arrival. When ask why a change of clothing was necessary, he stated that believed that Mr. Hill was scared. Mr. Hill never approaches responding Officers to identify himself as an Officer of the court, or to relay to responding Officers that a shooting accurred in self-defense, but flees the scene of the shooting

Police Database checks showed that the offender has a valid permit to carry #4600001115 issued in Montgomery County PA. (Expires: 11/15/27). The offender also has numerous .380 caliber firearms registered to him. .380 caliber matches the fired cartridge casing recovered at the crime scene.

On 9/20/23, the assigned, along with Det. Corson #605, Det. Ruddy #959, and Sgt. Zungolo #589, executed a search warrant at the offenders listed address located at 208 Garnet Ln in Bala Cynwyd PA. Det. Garner of the Lower Merion Police department, along with their ERT (Emergency Response Team) and SWAT (Special Weapons and Tactics), executed a search warrant in Montgomery County Jurisdiction. A black .380 Walther gun box, along with .32 caliber live ammunition was recovered in the master bedroom closet. Those items were later placed on Philadelphia Property Receipt, maintaining chain of custody with Lower Merion PD.

Based on the above facts and circumstances, your affiant believes sufficient probable cause exists, for the issuance of an arrest warrant of Leonard Keith Hill DOB: 11/04/1969 for aggravated assault and related charges.
