The Commonwealth of Pennsylvania by James B. Martin, District Attorney of Lehigh County, The People of Lehigh County and Lehigh County, Pennsylvania (hereinafter "Lehigh County") hereby submit this Notice of Appeal and Stay, for the purposes of alerting the Court and all parties to the stay imposed by virtue of Lehigh County's appeal of this Court's recent Orders, and to that extent alone, response to the Motion to Vacate.

Lehigh County filed an action in the Lehigh County Court of Common Pleas on March 23, 2018. On March 26, 2018, the Court granted certain defendants Joint Motion for Pretrial Coordination and Motion for Stay of Actions pursuant to Pennsylvania Rule of Civil Procedure 213.1. Certain parties, but not Lehigh County, filed motions, requesting that this Court appoint a "Leadership" committee of attorneys not hired by and unknown to Lehigh County.


On June 13, 2018, this Court entered two Orders—one ordering that Lehigh County's case be "coordinated" with other cases and the second ordering the appointment of a leadership committee of lawyers none of whom were hired by Lehigh County.

On June 14, 2018, Lehigh County filed an appeal as of right in the Pennsylvania Superior Court from these two Orders. By operation of Pa.R.Civ.P. 1701, the effect of Lehigh County's appeal is that this Court "may no longer proceed further in the matter". *Pa.R.Civ.P. 1701(a)*.

WHEREFORE, Lehigh County respectfully requests that this Court suspend all proceedings on this matter, including consideration of any additional matters respecting the two Orders on appeal.


