COMPLAINT

Plaintiff William J. Mansfield, Inc. ("Mansfield Advertising"), by and through its counsel Fox Rothschild LLP, hereby files this Complaint against defendant Udren Law Offices, P.C. ("Udren Law"). In support thereof, Mansfield Advertising alleges as follows:

1. Mansfield Advertising provides legal advertising services, including creating and publishing mortgage foreclosure notices in certain periodicals. Udren Law is a law firm that specializes in mortgage foreclosure. Mansfield Advertising regularly provided legal advertising services to Udren Law. This is an action to collect unpaid invoices for the legal advertising services provided by Mansfield Advertising to Udren Law.

PARTIES

- 2. Mansfield Advertising is a Pennsylvania corporation with its principal place of business located at 998 Old Eagle School Road, Suite 1209, Wayne, Pennsylvania 19087.
- 3. Udren Law is a New Jersey professional corporation with its principal place of business located at 111 Woodcrest Road, Cherry Hill, New Jersey 08003-3620.
- 4. Udren Law regularly transacts business in Pennsylvania, including with Mansfield Advertising and as counsel in mortgage foreclosure actions in the Commonwealth.

JURISDICTION AND VENUE

- 5. This Court has jurisdiction pursuant to 28 U.S.C. § 1332(a)(1); there is complete diversity of citizenship because the parties are citizens of different states and the matter in controversy exceeds \$75,000 exclusive of interests and costs.
- 6. Venue is proper in the Eastern District of Pennsylvania because a substantial part of the events and omissions giving rise to the dispute occurred in the Eastern District of Pennsylvania.

STATEMENT OF THE CLAIM

- 7. Pursuant to the parties' longstanding course of dealing, Udren Law requested that Mansfield Advertising create and publish notices relating to mortgage foreclosure actions in which Udren Law was acting as counsel.
- 8. Mansfield Advertising created and paid to publish Udren Law's mortgage foreclosure notices, invoicing Udren Law for its services after publication.
- 9. Udren Law has refused to pay Mansfield Advertising's outstanding invoices and has indicated that the firm is in the process of winding down and thus cannot provide guidance as to when, or if, it will pay the invoices.
- 10. Udren Law owes Mansfield Advertising \$139,357.74, which is the total owed from eighty-six (86) outstanding invoices for legal advertising services already provided (the "Invoices").
 - 11. See true and correct copies of the Invoices attached as Exhibit A.

COUNT I – BREACH OF CONTRACT

- 12. Mansfield Advertising incorporates by reference its previous allegations.
- 13. Udren Law and Mansfield Advertising had a valid and binding oral agreement for the provision of legal advertising services.

- 14. Mansfield Advertising performed under the agreement by providing legal advertising services and issuing invoices to Udren Law.
 - 15. Udren law breached the agreement when it failed and refused to pay the Invoices.

WHEREFORE, Mansfield Advertising respectfully requests that the Court enter a judgment in its favor and against Udren Law in the amount of \$139,357.74, plus pre-judgment interest, post-judgment interest, and any other relief as this Court deems just, proper, and equitable under the circumstances.

COUNT II – UNJUST ENRICHMENT

- 16. Mansfield Advertising incorporates by reference its previous allegations.
- 17. Udren Law requested that Mansfield Advertising provide legal advertising services knowing that Mansfield Advertising expected to be paid.
 - 18. Mansfield Advertising provided legal advertising services to Udren Law.
- 19. Udren Law received the benefit of Mansfield Advertising's legal advertising services without paying for those services.
- 20. Under these circumstances, it would be inequitable for Udren Law to retain such benefit without payment of value.

WHEREFORE, Mansfield Advertising respectfully requests that the Court enter a judgment in its favor and against Udren Law in the amount of \$139,357.74, plus pre-judgment interest, post-judgment interest, and any other relief as this Court deems just, proper, and equitable under the circumstances.
