With the support of my law firm, I have devoted a considerable portion of my career to pro bono work. I have served on my law firm's firmwide pro bono committee and as the pro bono coordinator of my firm's office. Through these roles, I have initiated numerous new pro bono programs, opportunities, and training for the attorneys in my law firm and in my city. By way of example, in my role as pro bono coordinator (and with the support of many of the associates at my firm), I initiated new pro bono programs involving veteran's benefits, immigrant asylum work, child custody, and "juvenile lifer" litigation following *Montgomery v. Louisiana*, 136 S. Ct. 718 (2016). During my time as pro bono coordinator, the local bar association awarded my law firm the award of pro bono law firm of the year.

Individually, I have performed a significant amount of pro bono work. I have had dozens of pro bono clients, and spend approximately, on average, 150 – 200 hours each year on pro bono work. By way of example, I have represented one pro bono client for nine years in matters in five separate judicial proceedings, spending over 400 hours of my time devoted to his case (which remains ongoing).

I have been appointed by the United States Court of Appeals for the Third Circuit on numerous occasions to represent prisoners in habeas litigation, and, in one case, was appointed by the court to serve personally as an amicus curiae in my own name, along with one of my partners. I have also been appointed by the United States Court of Appeals for the Sixth Circuit to serve on pro bono habeas and criminal cases, and for a time, I was appointed to serve on the pro bono panel of the United States Court of Appeals for the Second Circuit. I have been appointed by the United States District

Court for the Western District Court of Pennsylvania to serve as lead counsel in approximately thirteen pro bono civil rights cases. I also served as lead counsel in submitting an amicus brief to the Pennsylvania Supreme Court in a pro bono case on behalf of the Innocence Project.

I have also represented small religious institutions (typically, small house churches in urban areas with homeless shelters) that have been discriminated against on account of their religious beliefs and the race of their attendees.

Aside from my direct pro bono involvement, I spend a considerable amount of time on community volunteer activities. Since 2005, I have continuously served as a mentor to high school and middle school students in inner-city schools in Pittsburgh. One of my two “older” mentees is now a full-time minister, and the other one is an Army veteran who is currently a pre-law student, and who I continue to mentor as he embarks on a future career in the law. Both of these students graduated from David B. Oliver High School, which the 2010 documentary “Waiting for Superman” referred to as a “dropout factory.” I have also mentored a number of law students at both local law schools. I have provided informal mentoring to a number of other lawyers, law students, and paralegals in the community.

On May 24, 2017, I interviewed with the bipartisan commission in Pittsburgh, Pennsylvania. The bipartisan commission approved of my nomination, and my understanding is that it then referred my application to Senator Toomey’s office. On October 6, 2017, I interviewed with Senator Toomey and several of his staff at the Senator’s office in Allentown, Pennsylvania. On February 28, 2018, I interviewed with Senator Casey and several members of his staff at the Senator’s office in Washington, D.C. On March 16, 2018, I interviewed with staff from the White House Counsel’s Office and Office of Legal Policy of the Department of Justice in Washington, D.C. Since March 20, 2018, I have been in contact with officials from the Office of Legal Policy and the White House Counsel’s Office. On July 24, 2018, the President submitted my nomination to the Senate.
