NARRATIVE

Narrative

On Tuesday, May 8, 2018, at approximately 1020 hours, I, Sergeant M. Love#2399 was assigned to courtroom 8C located at 185 Central Avenue, Atlanta, GA 30303. At listed date and time, I was notified by Clerk of Courts employee Carmen Jones that an unknown black male later identified as Ruben Washington (D.O.B. 12/ /76) was attacking a white female (victim) identified as [redacted] on the elevator and lobby area on the 8th floor of the Fulton County Courthouse (136 Pryor Street, Atlanta, GA 30303).

I, Sgt. M. Love arrived and visually observed Judicial Manager DeAndre Royals restraining the suspect Ruben Washington. Suspect Washington was lying on his stomach with his hands behind his back. I placed handcuffs on the subject, searched and escorted him to the detention areas of courtroom 8C detention area located in the Fulton County Justice Center Tower. Mr. Royals also stated that he found a pair of scissor on the floor which he handed to Lt. S. Betts.

I, Sergeant M. Love interviewed the victim [redacted]. She stated to me that at approximately 1005 hours, she and a black male were waiting on the elevator on the 4th floor of the Fulton County Courthouse located at 136 Pryor Street. She stated that they both entered and when the elevator doors closed, the black male suspect placed her in a choke hold. She explained that he placed his hands around her neck in an attempt to cut off her breathing. [redacted] stated that she was screaming and pushing the elevator buttons to get help. When the elevator stopped on the 8th floor, the doors opened and Attorney Michael Katz intervened in the incident by separating the victim from her attacker. Attorney Katz stated that he placed the male attacker in a choke hold which allowed [redacted] to get away by crawling out of the elevator.

I interviewed Attorney Michael Katz and he stated that he did witness a black male attacking a white female on the elevators in the Fulton County Courthouse on the 8th floor. He also stated that the suspect was choking the victim with one hand and held a pair of blue scissors in his free hand. Attorney Katz also stated that there were papers and files scatter around [redacted]. Attorney Katz further stated that the victim was screaming for the man to get off of her. He intervened by placing his hands on the suspect's shoulders and pulled him off of the victim. Attorney Katz provided me with a written statement.

I, Sergeant M. Love interviewed the second person to arrive at the scene, Judicial Manager De Andre Royals. Mr. Royals stated he observed attorney Katz and suspect R. Washington involved in a physical altercation near the elevator on the 8th floor of the Fulton County Courthouse. Suspect Washington was attacking Attorney Katz and Mr. Royals stated he gave verbal commands to suspect Washington to stop. Then suspect Washington turned and attacked Mr. Royals. Mr. Royals stated that suspect Washington struck him in his lower left jaw with a closed fist. Mr. Royal stated that he was then to hold suspect Washington down until help arrived. Once I arrived on scene, I visually observed Judicial Manager DeAndre Royals restraining the suspect. Suspect Washington was lying on his stomach with his hands behind his back. I then placed handcuffs on the subject, searched and escorted him to the detention area courtroom 8C. Subject Washington was later escorted the detention area located on the ninth floor sheriff's Office..

I was informed by Sgt. T. Calloway #2772 that at approximately 12:00pm suspect Ruben Washington was escorted to Male Detention. While getting the handcuffs removed to be placed in a detention cell, suspect Washington punched Detention Officer J. Haynes #1090 in the face with a closed fist. Lt. S. Mattox#2483, Sgt. T. Calloway and D.O. Haynes had to physically restrain and reapply the handcuffs. Subject Washington was placed in a holding cell without further incident to await transport to the Fulton County Jail.
