1. _____ Defendant shall have no communication or contact with and shall stay away, absolutely, directly or indirectly, by person and telephone, from the person, home, and job of any victim, witness, or party to this matter.

2. _____ Defendant shall voluntarily submit to the immediate enrollment and participation in domestic violence counseling, substance abuse therapy, or other therapeutic requirements. It should be noted that any and all documentation relating to the attendance and/or completion of any of the aforementioned services shall be the responsibility of the Defendant to provide said documents to the trial court.

3. _____ Upon release from custody, Defendant hereby waives his or her fourth amendment rights under the United States Constitution and the Constitution of the State of Georgia and authorized law enforcement officers of this State shall have the right to search the Defendant's person and property.

4. _____ Defendant shall remain a student. If Defendant's education pursuits are terminated or completed, then the Habersham County Sheriff's Office will be notified within ten business days.

5. *guj* _____ Defendant shall not violate the Law of the State of Georgia or the United States.

6. _____ Defendant shall consume NO drugs except those specifically prescribed to the Defendant by a physician and in such event shall retain a copy of the prescription.

7. _____ Defendant shall consume no alcohol.
