(10333) who being first duly sworn deposes and says that on 3/23 to 7/12 (year) 2017 at 201 SE 6TH ST, FORT LAUDERDALE, FL 33301 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

obscene, filthy, vulgar, indecent and threatening voicemails and by posting the phone calls with the pictures of the judges on social media; Facebook, YouTube, Justice For All and Gang TV. The above stated victim judges were the judges that presided and or had involvement over the defendant's criminal case where he was found guilty and sent to prison.

VICTIM 1. The Honorable Judge Jeffrey Levenson

o On March 23, 2017 at approximately 12:37 pm, the stated defendant, Todd Edward Watson, sent The Honorable Judge Levenson an email. Listed below are only of few of the defendant's quotes:
"What's it like to be a judge, who's awaiting your imminent arrest and prosecution? Allowing a bailiff to ask U.S. citizens to "rise" honoring a flat out criminal to enter into a court room." It's undisputed and indisputable you orchestrated the most cold, calculated, evil criminal conducts and constitutional rights violations ever executed with a U.S. court room."

Attached to the Judge Levenson's email was also a copy of the email that the defendant sent to Broward County State Attorney Michael Satz. The first sentence states, "Your worst nightmare has come true, I'M FREE."

o On May 3, 2017 the Honorable Judge Sandra Perlman received a letter from the defendant and it was addressed to several Broward County Judges including Judge Levenson. Listed below are only of few of the defendant's quotes. The letter starts out:

(10333)** who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at **201 SE 6TH ST, FORT LAUDERDALE, FL 33301** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

"Re: Your ongoing criminal conducts"

"On 4/18/2017 I was attempting to perform my duties as an American (The citizen part you Traitors raped me from) by exposing your ongoing criminal conducts."

The defendant goes on to accuse the Honorable Judge Kenneth Gillespie of being a huge advocate of child molestation and he calls State Attorney Mike Satz, "Psycho Mike." Enclosed with the letters was a typed handout signed by the defendant. The handout was addressed to B.S.O Officers and Broward County Officers Of The Court. A few of the quotes are as follows:

"-The first ever State sanctioned act of Terrorism upon a U.S. citizen's business authorized by State Attorney Michael Satz (see exhibit e)."

"The list of colluding actual felony crimes goes on and on e.g.

-A,S.A. Denise Neuner fabricating official document's at the instruction direction of ASAIC John Gallagher

-Court reporters Michael happ, Sandra Digiamo and Vivian Rock fabricating evidence."

"The worst possible nightmare of colluding actors has happened, I`M FREE."

o On May 8, 2017 at approximately 7:08 am, the defendant left a voicemail on Judge Levenson`s

voicemail answering machine. Listed below are only of few of the defendant`s quotes:

"This message is for Jeffrey Levenson. This is Todd Edward Watson. This phone call is being recorded and will be sent to the FBI and several social media websites in regards to his colluding criminal conducts."

"You said that my writing style was malicious. Then, you orchestrated the most evil premeditated criminal conduct ever executed in a US courtroom during dependency of the

(10333) who being first duly sworn deposes and says that on _____ day of _____ (year) at 201 SE 6TH ST, FORT LAUDERDALE, FL 33301 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

State's emergency motion."

"I compared you to Hitler. Adolph Hitler in my opinion very appropriately." (It should be noted that Judge Jeffrey Levenson is Jewish).

"Obviously you know, the entire criminal justice system in Broward County is infested with corruption and corrupt people such as yourself. Uh, Michael Satz did in fact authorize the firebombing of my office to cover up a murder. The murder was of a 19-year-old male."

The defendant stated that he was going to call again.

o On May, 9, 2017 the defendant posted on YouTube and Facebook the voicemails that he recorded when he called Judge Levenson. The posting depicts a picture of Judge Levenson with the words, "co-conspirator Judge Jeffrey Levenson." When I went to You Tube I discovered that the following judges' pictures with the words Co-conspirator with their names, were placed on the pictures:

- o Judge Kenneth Gillespie
- o Judge Sandra Perlman
- o Judge David Haines
- o Judge Edward Merrigan
- o Judge Peter Weinstein

Another video shows the defendant sitting in a chair as he reads a script. Some of his quotes are as follows:

"The video footage you are about to see are actual felony crimes being committed by several officers of the court within the Broward County Courthouse on April 18, 2017. These criminal practices were performed in an effort to conceal the criminal conduct

(10333)** who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at **201 SE 6TH ST, FORT LAUDERDALE, FL 33301** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

surrounding my case that includes but is not limited to, the first ever US State sanctioned act of terrorism. State Attorney of Broward County Michael Satz authorized the firebombing of my business to cover up the death of a 19-year-old.
"The intentionally allowing a 4-year-old girl to be repeatedly molested."
"Special Prosecutor Denise Neuner fabricating every single official document filed with the clerk's office."
"I constructed a document written under the penalties of perjury explaining previously mentioned criminal conducts. The most prominent obviously being that Broward County State Attorney Michael Satz is in fact a terrorist and murderer."

During the recording, the defendant accuses two court reporters of fabricating their transcripts, he refers to three State Attorney Investigators as the three stooges and he accuses Judge Edward Merrigan, Judge Kenneth Gillespie and Judge Jeffrey Levenson of being co-conspirators.

"Um, you know I'm sure that you know that your face is posted on ah, social media websites."


"You Sick Bastard."

"What's it like to be living knowing full well you're living on borrowed time that you're going to die in prison Jeff? What, what's that like?"

During the phone call the defendant also calls the judge an idiot and he states that the Broward County Public Defender's office is also corrupt.

o On May 30, 2017 at approximately 6:48 am, the defendant left another harassing voicemail

on Judge Levenson's voicemail answering. The voicemail was for Judge Levenson's judicial assistant. Listed are only a few of Watson's quotes:

"You have been listening to the phone calls that I have left, the undisputed indisputable facts about the including the criminal conduct of Judge Jeffrey Hitler Levenson."

The defendant talks about his motion not being filed and he instructs Ms. Quintero to go to YouTube and Facebook to view his videos that he has posted one of which he calls State Attorney Michael Satz a Terrorist/Murderer. The defendant tells Ms. Quintero that by her not taking the appropriate action, she is committing two felonies. The defendant ends the call by stating:

"I'm not happy today so you're now implicated mam. If you don't take certain actions, well you're in trouble."

o On June 13, 2017 at approximately 6:36 am, the defendant left another harassing, obscene, filthy, vulgar and profanity laced vile voicemail on Judge Levenson's voicemail. The voicemail also contained racial slurs. The defendant tells Judge Levenson's judicial assistant that the judge is a psychopathic criminal and a habitual liar. Once again he calls the judge, "Jeffrey Hitler Levenson." The defendant stated that Judge Levenson lied his ass off in court and that lies were told and crimes were committed. One of the defendant's quotes is as follows:

"Remember that Jeff, you sack of shit. Anyway, so yea listen, you can give this recording to the psychopathic criminals at the Broward Sheriff's Office of course so



o On June 13, 2017 at approximately 6:47 am, the defendant called again and left another harassing, obscene, filthy, vulgar and profanity laced vile voicemail on Judge Levenson`s voicemail. The voicemail also contained racial slurs. The defendant starts out by calling Judge Levenson, "Jeffrey Hitler Levenson" and a "Sick Fuck" The defendant accuses the three court reports involved in his case of fabricating transcripts. Some of the defendant`s quotes are as follows:
"Jeffrey Hitler Levenson that scumbag did not have jurisdiction to resentence me he was going to die in prison with the rest of the filthy slime."
"I mean does it bother you Alisa that um you`re, you`re, that, that Jeff is an admittedly and in fact a psychopathic criminal, a compulsive habitual pathological lying sack of shit and a treasonous traitor."

o On July 4, 2017 at approximately 6:32 am the defendant called again and left another harassing, obscene, filthy, vulgar and profanity laced vile voicemail on Judge Levenson`s voicemail answering machine. The voicemail also contained racial slurs. The defendant starts out by stating that Broward County Sheriff is a co-conspirator and he calls the Honorable Judge Jeffrey Hitler Levenson, "Jeff, Jeffrey Hitler Levenson." The defendant refers to State Attorney Michael Satz as a, "Murdering Fucking Terrorist" and he calls Public Defender Howard Finkelstein a "Pussy." Most of the defendant`s

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

voicemail contains the words fuck and fucking. Some of the defendant's quotes are as follows:

"Jeffy, Jeffrey Hitler Levenson, It's the 4th of July and I'm particularly pissed fucking off this morning Jeff."

"Hey so listen uh you're a, you're a, a civil judge now. What a fucking tragedy that is not to have you in criminal court, huh. Fucking scum bag."

"Of course you've got Peter Weinstein, the filthy pig that he is..What a fucking scumbag he is."

"Happy 4th of July you are in fact a treasonous traitor to both your country and you're profession. You're a scum bag. You're a lying sack of shit and you're a psychopathic criminal."

Watson accuses the three court reporters that were involved in his case of fabricating transcripts. Watson refers to members of the JQC" as, "Filthy Fucking Slim"







o On May 3, 2017 The Honorable Judge Sandra Perlman received a letter from the defendant and it was addressed to several Broward County judges including Chief Judge Peter Weinstein. Listed below are only of few of the defendant's quotes. The letter starts out:

"Re: Your ongoing criminal conducts"

"On 4/18/2017 I was attempting to perform my duties as an American (The citizen part you Traitors raped me from) by exposing your ongoing criminal conducts."

The defendant goes on to accuse the Honorable Judge Kenneth Gillespie of being a huge advocate of child molestation and he calls State Attorney Mike Satz, "Psycho Mike."







It should also be noted that the numerous phone calls served no legitimate purpose and their contents were left with the intent to harass and intimidate the Honorable Judge Tim Bailey, the Honorable Judge Andrew Siegel, the Honorable Judge Ernest Kollra, the Honorable Judge Martin Fein and the Honorable Judge John Bowman.

The Honorable Judge Tim Bailey, the Honorable Judge Andrew Siegel, the Honorable Judge Ernest Kollra, the Honorable Judge Martin Fein and the Honorable Judge John Bowman stated that they concerned for their and their judicial assistant`s safety and they do wish to prosecute the stated defendant, Todd Edward Watson. The stated judges signed victim affidavits.
