"Jeffrey Hitler Levenson that scumbag did not have jurisdiction to resentence me he was going to die in prison with the rest of the filthy slime."

"I mean does it bother you Alisa that um you're, you're, that, that Jeff is an admittedly and in fact a psychopathic criminal, a compulsive habitual pathological lying sack of shit and a treasonous traitor."

On July 4, 2017 at approximately 6:32 am the defendant called again and left another harassing, obscene, filthy, vulgar and profanity laced vile voicemail on Judge Levenson's voicemail answering machine. The voicemail also contained racial slurs. The defendant starts out by stating that Broward County Sheriff is a co-conspirator and he calls the Honorable Judge Jeffrey Hitler Levenson, "Jeff, Jeffrey Hitler Levenson." The defendant refers to State Attorney Michael Satz as a, "Murdering Fucking Terrorist" and he calls Public Defender Howard Finkelstein a "Pussy." Most of the defendant's

"Ed,

It's not a military secret I despise your existence as a psychopathic criminal who presides as a judge determining the punishment of person's who's crimes don't come close in comparison to the ones you have committed."

Watson ends the first letter by stating:

- On May, 9, 2017 the defendant posted on YouTube and Facebook the voicemail that he recorded when he called Judge Merrigan. The posting depicts a picture of Judge Merrigan's with the words, "co-conspirator Judge Edward Merrigan." When I went to You Tube I discovered that the following judge's pictures with the words Co-conspirator with their names, were placed on the pictures:

On Friday, June 23, 2017 at approximately 5:51 am, the defendant called Judge Edward

Merrigan's voicemail answering machine and he left another harassing voicemail. Some of the defendant's quotes are as follows:

"I guess Ed is not going to do anything to, to expedite his own prosecution obviously. You should have seen the look on his face when he saw me in the courtroom." "Ed is in fact intentionally breaking the law."

"He knows he's a treasonous traitor and he knows he's breaking the law. Until he gets arrested there's nothing that I can do about that. But uh, anyway, your ass is on the line Denise. You know I mean and I'm going to have absolutely zero sympathy for you. None. Zero and who what, what you going to give this to the sheriff's office who is colluding their criminal conducts or the public corruption division which is the most corrupt division inside the criminal justice system this country has ever known." Watson accuses Judge Merrigan of being a co-conspirator.

- o It should be noted that I have recorded 34 harassing, obscene, filthy, vulgar and profanity laced vile voicemails from the defendant that he has left for six judges and the Broward County Clerk of Court. The voicemail also contained racial slurs. defendant refers to a Jewish judge as "Hitler" and an African American judge as "Uncle Tom." He also calls the judges, a "Compulsive Habitual Pathological Lying Sack of Shit and a Treasonous Traitor," a "Sick Bastard, a "Psychopathic Criminal and a Habitual liar," a "Sick Fuck," a "Fucking Scumbag" and a "Fucking Pussy." It should be noted that the defendant left the stated voicemail messages, he identifies himself by name and he list his phone number. The defendant's phone number is also shown on the voicemail called id.
