### NEW YORK | CONTRACTS

#### Sealing of Documents Granted and Denied In Part in Breach of Contract Action

Plaintiffs brought a breach of contract action related to plaintiffs' investment in defendants' continuation fund. Defendants moved to seal documents. Plaintiffs opposed the motion. The motion was granted in part and denied in part. The court held, upon review of the documents sought to be sealed and the defendants' redactions together with plaintiffs' opposition to sealing, good cause existed under 216.1 of the Uniform Rules of Trial Courts for sealing all of the documents, except for the letter agreement. Defendants were primarily seeking to partially seal confidential financial information and the names of nonparties. In those instances in which defendants sought to seal information that was already public-facing in the complaint, such information went to the parties' central arguments, good cause was not sufficiently established.

### NEW YORK | TRUSTS AND ESTATES

#### Martial Trust Turned Into Unitrust Pursuant To Decedent's Intentions

Petitioner, as the independent co-trustee of the Non-GST Marital Trust created under paragraph 1 of Subdivision A of Article VI of the declaration of trust creating the Raymond R. Herrmann, Jr. Revocable Trust, brought a proceeding for conversion of the Marital Trust into a unitrust pursuant to EPTL 11-2.4(e)(2)(B). The petition was granted. The court held half of the Marital Trust's substantial assets consisted of shares held in the decedent's company which would be repurchased within the next three years. As a result, the liquid, investable assets in the Marital Trust were anticipated to substantially increase. It was clear from the terms of the Marital Trust that the decedent intended to provide for trustee during her lifetime. Converting the Marital Trust into a unitrust would facilitate the independent co-trustee's ability to invest these assets while providing for the trustee with adequate resources to enjoy her standard of living.

### U.S. - SDNY | CIVIL PROCEDURE

#### Home Confinement Credit Properly Declined; Credit Not Entitled to; Counsel Not Deficient

Garraway's Dec. 13, 2021, petition for 28 USC §2255 habeas relief sought vacatur of his sentence of 36 months' imprisonment and three years' supervision. Garraway argued that he did not receive credit for time spent on home confinement, and that his attorney did not argue therefor at sentencing. A review of the Bureau of Prisons Inmate Locator shows Garraway was released from custody on May 19, 2023, and is currently on supervised release. The court denied petitioner Garraway's §2255 motion to vacate his conviction. Rather than a direct challenge to the imposition of sentence, the court viewed Garraway's motion as a challenge to the calculation of sentence. Given that the court is not authorized to compute credit at sentencing, it properly declined to credit Garraway's time spent in home confinement. As Garraway failed to exhaust administrative remedies, the court also lacked jurisdiction to review the BOP's decision not to credit his home confinement. Garraway is not entitled to credit for time spent in home confinement. Thus, counsel was not shown deficient for failing to argue for such credit on Garraway's behalf.

### U.S. - EDNY | CIVIL PROCEDURE

#### Action Is Remanded to Criminal Court in Queens; 28 USC §1443 Removal Not Satisfied

Two counts of criminal possession of a weapon in the second degree, criminal possession of a weapon in the third degree, and two vehicle-related charges against Chambers arose from events occurring on Oct. 19 or 21, 2022, in Queens. Appearing pro se, and having paid the filing fee, Chambers sought to federally remove his pending criminal action from the Criminal Court of the City of New York, Queens County to the instant district court. District court remanded action to the Criminal Court in Queens. Chambers failed to satisfy the two prongs for removal set out in 28 USC §1443, and determined that his "entirely conclusory" allegations could not justify removal under §1443. Chambers did not allege facts allowing the court to find that his state court prosecution violated any federal right to be free from racially based discrimination. Nor did Chambers link his perception of discrimination to any facts that police were motivated by race when they arrested him. Chambers' allegations did not satisfy §1334(1)'s removal requirements. Thus his case must be remanded.

### NEW YORK | CONTRACTS

#### Court Rules That Petitioner Is Not Subject To Arbitration Agreement Clause

Petitioners brought a breach of contract action arising from an interior design services agreement. Petitioners moved to permanently stay arbitration proceedings against them. Respondent cross-moved to compel petitioner to participate in the arbitration proceedings, or in the alternative to sever and convert respondent's conditional counterclaims into a plenary action. Petitioner's motion was granted. The court held applying the 'alter ego' test, respondent failed to show that, even if petitioner dominated her company, that control resulted in some fraud or wrong mandating disregard of the corporate form in the case. Petitioner's actions of using her personal name and address and advertising projects she completed for her family did not raise to an inference of abuse of the corporate form, or that the company was not formed for legal purposes or did not engage in legitimate business. Thus, respondent had not met her heavy burden and the agreement to submit to arbitration cannot be imputed to petitioner.

### KINGS | IMMIGRATION LAW

#### Petition Denied, Adjudication on Ancestry Was An Impermissible Advisory Opinion

Petitioner, who was in the process of seeking dual citizenship from Italy applied to the State Supreme Court for an order to declare that various family members, whose names were listed differently on various birth, marriage, and death records, were one and the same person. This was due to Italy's requirement that discrepancies in vital records submitted to prove Italian heritage be addressed by a court. The court noted that CPLR provisions pertaining to declaratory judgments, relied on by petitioner, applied only to actual controversies and that granting the relief sought would constitute the impermissible issuance of an advisory opinion. There was no statutory authority for petitioner to bring her application as a special proceeding, it was not brought against anyone, and she did not even seek to have vital records corrected. The court denied petitioner's application as there was no jurisdiction to grant the relief of issuing a one and the same order.

### U.S. - SDNY | CONTRACTUAL DISPUTES

#### Anticipatory Repudiation Claim Is Duplicative Of Surviving Contract Breach Claims

Zoomcar Inc. allegedly failed to pay consultant Yanker a contingency fee pursuant to their 2020 "Consulting Agreement" in connection with a 2021 transaction in an unregistered securities offering (2021 Corporate Transaction) and an October 2022 Merger (2022 Corporate Transaction), by which time Zoomcar had terminated the Consulting Agreement, in writing, on Jan. 7, 2022. Alleging breach of the 2021 and 2022 Corporate Transactions as well as anticipatory breach, Yanker sought declaratory judgment that he has a continuing right to be paid under the Consulting Agreement. The court denied Zoomcar dismissal of Yanker's two causes of action for breach of the 2021 and 2022 Transactions, but dismissed Yanker's claims of anticipatory breach and for a declaration of his continuing right to payment. As to the two breach causes of action the Consulting Agreement was not unenforceable due to illegality, and resolution of a provisional conflict must await discovery. Yanker's anticipatory repudiation claim was dismissed as duplicative, and the factors in *Admiral Insurance* weighed against exercise of jurisdiction under the Declaratory Judgment Act.

### U.S. - NDNY | DISCOVERY

#### Incomplete Discovery Prevents Full Response To Copyright, Trademark Infringement Claims

Plaintiff Office Create Corp. sued 1st Playable Productions and others alleging direct and contributory copyright infringement, direct and contributory trademark infringement, and other violations of the Copyright and Lanham Acts and common law. Plaintiff's instant motion under FRCP 56 sought partial summary judgment as to defendants' alleged infringement of its copyright as to the Cooking Mama: Cookstar game for use on Sony PlayStation 4 and Nintendo Switch gaming platforms. The court denied plaintiff's motion without prejudice. Notably, Office Create did not respond to defendants' discovery requests, produced no witnesses for deposition, nor established its ownership of the copyright at issue. The absence of discovery prevents defendants' full response to plaintiff's motion for summary judgment, which is therefore dismissed. Defendants have repeatedly stated how it is that the lack of full discovery has prevented or impeded them from forming adequate, complete responses to plaintiff's stated facts.

### NEW YORK | DISPUTE RESOLUTION

#### Court Confirms Arbitration Award As Respondent Did Not Oppose Petitioner

Petitioner brought a petition to confirm an arbitration award made by an arbitrator acting under the auspices of the Mediation and Civil Arbitration, Inc. (MCA). The respondents did not oppose the petition. Petitioner entered into an agreement with the respondent to which petitioner agreed to purchase \$41,322.00 of respondent's future receivables for the sum of \$29,100, less service fees in the sum of \$1,931. Respondent defaulted. Arbitration commenced which was found in favor of petitioner when respondent did not show up. The petition was granted. The court held petitioner contended that the award was proper in all respects and that no grounds existed for modification or vacatur. The court agreed with petitioner, and concluded that petitioner was entitled both to the confirmation of the award, and the entry of a money judgment in the sum of \$48,887.69, as awarded by the arbitrator.

### KINGS | LANDLORD TENANT LAW

#### Eviction Denied, Tenant's Conduct Not Found Deleterious For Other Tenants

Petitioner brought a holdover eviction proceeding against respondent for breach of lease. Respondent moved to dismiss. Petitioner alleged that the tenant created a nuisance and violated a substantial obligation of her tenancy pursuant to 9 NYCRR 2524.3 (a), (b), and (e) by having a washing machine which caused flooding and damage in the apartment, and by failing to provide proper access to abate Housing Quality Violations and Housing Maintenance Code violations. The motion was granted. The court distinguished between curable and incurable conduct noting in addition to a pattern of continuity or recurrence of objectionable conduct, the tenant's conduct must be deleterious to other residents. Furthermore, the court rejected the petitioner's argument that the landlord requested access after the cure period expired were not sufficient to satisfy common law tests concerning the matter.

### U.S. - EDNY | CIVIL PROCEDURE

#### Public Disclosure Bar Underlies Dismissal Of 2008 FCA Qui Tam Action's Claims

Hanks was a sales representative for Amgen Inc. In 2008, as relator, he brought a qui tam action against Amgen under the False Claims Act and various states' analogues. His latest amended complaint alleged that defendant oncology practices, healthcare providers, and group purchasing organizations (collectively Provider Defendants) conspired with Amgen to buy Amgen's drugs at discounted rates knowing that Amgen would not report those discounts to government agencies. The unreported discounts allegedly constituted kickbacks violating the Anti-Kickback Statute. Upon remand from Second Circuit, district court dismissed Hanks's FCA claim for lack of subject matter jurisdiction. Hanks was not an original source. Thus the public disclosure bar in the pre-2010 False Claims Act applied. Numerous civil lawsuits and news reports filed or published before 2008 contained the same or similar allegations as those in Hanks's complaint. Further, Hanks did not satisfy the three element original source analysis in *Piacentile v. U.S. Oncology*.
