

DECISIONS OF INTEREST

NEW YORK | EMPLOYMENT LITIGATION

Arbitration Stayed, Relief Sought Would Have Been Violation of Public Policy

Petitioner, the State of New York Unified Court System, brought a special proceeding seeking to stay permanently arbitration sought by respondent, Civil Service Employees Association, Inc., on behalf of its union member arising from petitioner's decision to "re-designate" the member's job title from "Principal Law Clerk to Judge" to "Associate Court Attorney." The petition was granted. The court held contrary to respondent's assertions, such relief clearly implicates petitioner's discretionary authority to administer its operations by establishing and supervising job title standards, and therefore arbitration was precluded by public policy. Respondent's argument that the union member merely sought to keep his salary static until his Associate Court Attorney salary reaches the salary he had when he was re-designated, would implicate a violation of State Finance Law § 200.3(a). Respondent's laches argument failed as its notice of intention to arbitrate failed to include a 20-day preclusion from objecting.

BRONX | LITIGATION

Claim Dismissed, Claimant Failed to Show She Was Owner of Dog Nor It Was Sick

Claimant testified that she took her elderly dog, Bailey, to defendant for two years prior to the incident at issue. Bailey died unrelated to this action as he was suffering from kidney failure. Claimant testified that she is seeking return of the cost of the grooming services and the cost of veterinary bills as she claims the dog became ill from the grooming services and the grooming equipment. Defendant testified in her defense, she groomed Bailey for over 2 years without incident, treated him well and did the grooming personally according to protocol without incident. Claimant produced photos and documents that showed she was not the owner of Bailey. No certified medical documentation for Bailey's illness was submitted. Hence, claimant failed to prove a *prima facie* case. Based on credible testimony and evidence, the claim was dismissed.

SECOND CIRCUIT | CRIMINAL LAW

Search of SD Memory Card Fell Within Warrant to Search Cell Phone

In March 2022 Tompkins was principally sentenced to 120 months in prison for failing to register as a sex offender and possessing child pornography. On appeal he argued that district court should have suppressed images found on a SunDisk flash memory card (SD card) inserted into the back of his Samsung cellular phone because the search warrant that authorized the search of the phone did not separately identify the SD card as a place to be searched. Second Circuit affirmed judgment. The warrant authorized the search of the cell phone so as to recover specified information, in whatever form and by whatever means that information was created or stored, including any form of electronic storage. Thus the search of the SD card, itself a form of electronic storage inserted into and attached to Tompkins' cell phone, fell within the scope of the search warrant. By using the terms "electronic storage," "flash memory," and "other media" to describe the ways in which a cell phone may create and store electronic information, the search warrant contemplated a search of not only the phone itself, but also any SD card inserted therein.

U.S. - NDNY | PERSONAL INJURY

Negligence, Wrongful Death Claims Barred By Intramilitary Immunity, 'Feres' Doctrine

Ross administers the estate of C.N. In January 2021 C.N. was a 19-year-old U.S. Army Private when she was sexually assaulted by "Sergeant John Doe" at Fort Drum. C.N. took her own life on Oct. 27, 2021. Invoking the Federal Tort Claims Act, Ross asserted a claim of "intentional acts" against Doe; a claim of negligent hiring, training, supervision and control against the Department of the Army; and a claim of wrongful death against the Army. The court granted defendant United States' motion to dismiss the negligence and wrongful death claims (Counts II and III) for lack of subject matter jurisdiction and for failure to state a claim. Plaintiff's claims against the U.S. were barred by intramilitary immunity under the *Feres* doctrine. As with Count II the alleged negligence with respect to Count III occurred at the time of the alleged sexual assault. That C.N.'s alleged mental health issues and eventual suicide occurred off-base and after service ended was insufficient to overcome the *Feres* doctrine.

NEW YORK | CONTRACTS

Summary Judgment Granted, Defendant Did Not Waive Executed Leasing Commission

Plaintiff brought an action arising out of allegations for breach of contract. Plaintiff moved for summary judgment on its breach of contract, breach of the covenant of good faith and fair dealing, and unjust enrichment causes of action. Defendants opposed the motion and moved separately for summary judgment dismissing the complaint in its entirety. Defendant's motion was granted. The court held it was not persuaded by plaintiff's argument that requiring plaintiff to comply with the terms of the agreement would be futile, nor was the court convinced that defendants waived its right to the executed leasing commission agreement identified in the agreement.

Plaintiff Sufficiently Pleading Causes of Action Against Defendant Concerning Property

Plaintiff brought an action for quiet title and to seek a declaratory judgment. The dispute between the parties arose in connection with a proposed development project on defendant's property. Defendant moved for an order dismissing the plaintiffs' complaint. The motion was denied. The court held that the attached summons and complaint stated a cause of action for declaratory relief. The facts alleged in the complaint established a justiciable controversy and cause of action for declaratory judgement. The court also found that the complaint sufficiently alleged causes of action sounding in adverse possession, the doctrine of practical location, and declaratory relief against defendant. Moreover, the arguments and evidence proffered by defendant do not utterly refute plaintiff's allegations or conclusively establish a defense as a matter of law.

Wind Farm Opponent Lacks Standing To Pursue Claims Against 'Federal Defendants'

Opposing construction of a wind farm off Long Island, Kinsella sued the Department of the Interior, its Secretary, and its Bureau of Ocean Energy Management (Federal Defendants). The wind farm's developer, South Fork Wind LLC (SFW) intervened as a defendant. In response to defendants' motion to dismiss suit for lack of standing, and failure to state a claim, Kinsella sought to file a second amended complaint. Having considered his simplified claims, the court held that Kinsella lacks standing to pursue his claims against the Federal Defendants. Federal jurisdiction extended to only that portion of the wind farm project situated on the outer continental shelf. However, Kinsella's injuries—PFA contamination of groundwater—were traceable to New York Public Service Commission, which had exclusive jurisdiction over onshore trenching of the "Export Cable." Many of the allegedly fraudulent statement that Kinsella cited were made in SFW's submissions to the Federal Defendants. Nothing supported SFW intended the Federal Defendants to relay those statements to Kinsella, or for Kinsella to rely on them.

Dismissal of Homeowners' Claims Against Insurer, Stemming From Burst Pipe Explained

On Dec. 12, 2022, plaintiffs bought a home—as a "fixer upper" they planned to renovate—as their permanent residence. A Feb. 5, 2023, water pipe burst caused extensive damage. Insurer Liberty denied their claim that October. During the time taken to make a finding of coverage, the condition of the premises worsened. Plaintiffs sued Liberty on Dec. 1, 2023. Instantly district court dismissed, without prejudice, plaintiffs' claims for breach of fiduciary duty, violations of New York Insurance Law § 2601 and General Business Law § 349, and 11 CRR-NY 216/0 as well as their claims seeking punitive damages and attorneys' fees. Plaintiffs did not allege facts establishing a special relationship with Liberty giving rise to a fiduciary duty. Also, their legally unsupported claim for "quality of life" damages duplicated their claim for contractual breach damages. Further, Insurance Law § 2601 does not provide for a private right of action, and plaintiffs' GBL§349 claim was inadequately pleaded. Their conclusory allegations did not identify the allegedly fraudulent reasons that insurer Liberty denied their claims.

Documents, Affidavits Enough to Establish Plaintiff's Right to Summary Judgment

Plaintiff brought an action to foreclose on a mortgage encumbering residential real property located at 120 Riverside Boulevard in Manhattan given by defendant Chang Tae Seo to non-party Mortgage Electronic Registration Systems, as nominee for non-party Flagstar Bank, FSB. The mortgage secured an indebtedness in the original principal amount of \$625,500.00 and was evidenced by a note. Plaintiff moved for summary judgment. The motion was granted. The court held the argument that plaintiff failed to demonstrate all the elements of a cause of action for foreclosure was without merit. The affidavit and proffered business documents were all in admissible form. Likewise, the claim that the affiants lacked the requisite knowledge to support their information was unavailing.





QUEENS | INSURANCE LITIGATION

Questions of Fact Whether Bus Caused Party's Injury, Summary Judgment Denied

Plaintiff commenced an action to recover no-fault benefits for medical services rendered to injured party. The complaint stated that the injured party was injured in a motor vehicle accident. The injured party fell when stepping off a bus. Defendant sought summary judgment dismissing claim for no-fault benefits. Defendant claimed that the cause of the fall was a broken or uneven sidewalk or curb, and not the result of the operation of the bus. The injured person stated that the cause of the fall was a shift in the bus, as he was alighting from the bus. The motion was denied. The court found that there was a question of fact whether the injuries were caused from the use or operation of the bus; there was a clear allegation that the bus moved while the injured party was exiting.

Claims Fail; Remedies Not Exhausted; FMLA Retaliation Sufficiently Alleged in FAC

The non-governmental Wildlife Conservation Society (WCS) operates various zoos in New York City. Carillo was a full-time employee in the security department of the Prospect Park Zoo. She was terminated in May 2023. In addition to breach of fiduciary duty, Carillo sued the WCS for violating the Family and Medical Leave Act (FMLA), the Americans with Disabilities Act, Title VII of the Civil Rights Act, and the Equal Pay Act (EPA). Partly granting WCS's dismissal motion, the court concluded that Carillo's ADA and Title VII claims failed because she did not exhaust administrative remedies, and that she failed to state a claim under the FMLA. She did not allege WCS denied her any FMLA benefit to which she was entitled. Nor did Carillo's first amended complaint (FAC) allege that WCS improperly interfered with her right to reinstatement. However, the FAC sufficiently alleged FMLA retaliation. Also, Carillo's EPA claim was insufficiently alleged. She did not allege what her job duties were, much less those of her male comparators, and her claim that she was denied promotion because of her sex is not actionable under the EPA.
